Paraplegic Centre Peshawar invites bids through EPADS (Pak Acquisition and Disposal System) of Takaful & Insurance Companies to quote their rates for Group Health Coverage & Group Life Insurance of the Centre's Staff. The rates should be inclusive of all taxes. Only company with rating A & above from the rating agencies of Pakistan can participate in the Process. Registered with the Securities and Exchange Commission of Pakistan (SECP) for providing Takaful/Insurance services, Federal Board of Revenue (FBR) for Income and Sales Tax and appearing on the Active Taxpayer List (ATL), Khyber Pakhtunkhwa Revenue Authority (KPRA) and Registered and active on E-PADS as per KP-PPRA rules.

Bids Shall be uploaded on E-PADS not later than 11:00 AM, November 24<sup>th</sup> & 25<sup>th</sup>. The bids will be opened on the date and time mentioned below, in the presence of bidders or their authorized representatives at the Office of the Chief Executive Officer, Paraplegic Center.

### **Terms and Conditions**

1. All bidders are requested to submit their most competitive bid with the instruction incorporated herein.
2. Only typed tender on original Letter head and signed (Every page) should be uploaded, hand written quotation will not be entertained.
3. The firm must submit original Call Deposit Receipt (CDR) to the center's Procurement office, prior to the tender opening, otherwise the bid will not be acceptable. No Pay Order and Cheque shall be accepted and bid shall be rejected.
4. Bidding documents can be viewed/download from the official E-Pak Procurement Acquisition & Disposal System (EPADS) i.e. (kp.eprocure.gov.pk).
5. Income tax and sales tax registration must be provided.
6. If any company is engaged in any litigation with health department, its details must be provided.
7. The Centre reserves the right to reject all the bids, as per section 47 of the KPPRA rules 2014, after assigning valid reasons.
8. Quoted rates should include all applicable taxes.
9. The Income Tax, stamp duty and professional tax or any Government tax will be charged as per rule. (Only those firms will be honored that are on Active Taxpayer's List of FBR).
10. No conditional tender will be accepted.
11. The successful bidder will be bound to execute agreement on the stamp paper.
12. Bidding will be conducted through single stage-two envelopes bidding procedure as per Khyber Pakhtunkhwa procurement of Goods, works and Services rules for Group Health Insurance.
13. Companies should clearly mention their office address and phone numbers on their letter heads.
14. PCP will go for agreement with selected company for the period of one year.
15. Quoted company must provide its updated status of PACRA ratings and company profile.
16. Payment shall be made through cross cheque on the name of business account of Supplier/company in quarterly installments.
17. Reimbursement of claims must be cleared within 15 working days of period by the insurance company.
18. Bids will be evaluated on the basis of below mentioned required documents. Bids missing any of the below mentioned documents shall not be considered for the technical evaluation purposes.

## **CONTRACT DURATION**

The Successful bidder shall enter to a security service contract of One (01) year, however the contract will extend further for the period of One (01) year, subject to satisfactory past performance and cost validity

## **TERMS OF PAYMENT**

All kind of contribution dues shall be settled on quarterly basis along with fluctuation. The contribution of 2nd quarter shall be paid once the claims of 1st quarter are fully paid, and so on.

## **AWARD OF TENDER**

For the purpose of award of tender, the Best Evaluated Bid amongst qualified bidders shall be accepted for the award of tender

The management of Paraplegic Centre Peshawar / Procurement Committee will award the Insurance contract to the respective company based on comparative lowest bid submission of total sum amount of Group Health Financial Proposal, For the purpose of award of tender, the Best Evaluated Bid amongst qualified bidders shall be accepted for the award of tender.

## **PERFORMANCE SECURITY**

The successful Insurer shall furnish Performance Security as under:  
Within Thirty (30) days of the receipt of the Acceptance Letter from the Paraplegic Center Peshawar, in the form of a Bank Guarantees or CDR issued by a scheduled bank operating in Pakistan, for a sum equivalent to 10% of the total value of the premium per year; and denominated in Pak Rupees.

### ***i. Technical Evaluation Criteria***

The Bidders who have duly complied with the Eligibility/Qualification and Evaluation Criteria will be eligible for further processing. The Bids which do not conform to the Technical Specifications or Bid terms & conditions or the Bids from the Bidders without adequate capabilities for supply and maintenance / warranty services will be rejected.

The Eligible/Technically Qualified Bidders will be considered for further evaluation.

### **REQUIRED COVERAGE FOR GROUP HEALTH**

1. Coverage = Employee, spouse and children.
2. Hospitalization Limit = Rs. 500,000/- including miscellaneous charges, for all staff, their spouses and children (each).
3. One month before and after hospitalization treatment including diagnostic tests for the same disease/ailment would be included in the hospitalization.
4. Pre- existing conditions fully covered (disclosed and undisclosed).
5. Room = Deluxe Room \* Entitlement of Deluxe Room instead of Room Limit for all KPK Hospitals. For assurance Group Health card will be provided as a sample, for rest of Pakistan Rs. 12,000/- will be the Room Rent Limit (Per Day).
6. Maternity: Normal Delivery = Rs. 80,000/-, C- Section and complicated deliveries = Rs. 140,000/-
7. Maternity coverage of the previous year must be covered along with Pre Natal and Post Natal (Comprehensive Package, with no limit of Coverage Period) along with the coverage of (\* Provision of Previous comprehensive maternity coverage, if any pendency or in process from last year will settle in current service provider.)
8. Treatment charges of new born should be covered from his/her own hospitalization limit instead of charging it to the maternity limits of the mother.
9. No waiting period for maternity coverage. Disclosed and undisclosed, all to be covered.
10. New born to be covered from baby own limit at the birth time by covering circumcision.
11. Congenital illnesses for new born and onwards to be covered.
12. All accidental and medical emergencies to be covered in the hospitalization limit.
13. Laboratory tests of Hepatitis B & C to be covered in the hospitalization limit if they are positive.
14. MRI, CT scan, Covid tests and all-day care surgeries to be covered in hospitalization limit.
15. Company must provide 24 hours customer support.
16. Exclusion list should be provided with technical proposal.

**Note: If any of the above required coverage is missing, proposals/quotations will be rejected in technical evaluation stage.**
